Dear Sir / Madam,

Pursuant to the provisions of Regulation 30 of the SEBI LODR Regulations, we would like to inform you that Duet India Hotels (Ahmedabad) Private Limited, Duet India Hotels (Chennai OMR) Private Limited, Duet India Hotels (Pune) Private Limited and Duet India Hotels (Hyderabad) Private Limited, subsidiaries of the Company and Duet India Hotels (Jaipur) Private Limited, a step-down subsidiary of the Company have, *inter-alia*, signed management agreements ("Agreements") with Marriott Hotels India Private Limited and its affiliates ("Marriott") in relation to their assets situated in Ahmedabad, Chennai OMR, Chennai Mahindra World City, Pune, Hyderabad and Jaipur, respectively ("Assets"). This would entail transition of the Assets from a franchise model to a hotel to be managed and operated under the supervision, direction and control of the Marriott.

Further, the assets situated in Pune and Jaipur are proposed to be rebranded in accordance with the terms of the Agreements. Given below are the brief details of the planned conversion and rebranding (as applicable).

## SAMHI Executes Agreement with Marriott for Rebranding Two Hotels

**Gurugram, 18<sup>th</sup> July 2024** — SAMHI Hotels Ltd, a prominent hotel ownership and asset management platform in India, has informed exchanges about entering into agreements for the rebranding of two of its hotels acquired as part of ACIC portfolio. This follows SAMHI's core strength and proven experience of acquisition and turn-around of hotel assets.

Pursuant to the above, SAMHI has entered into a management agreement with Marriott for the rebranding of its 217 rooms hotel in Pune to a Courtyard by Marriott branded hotel. The conversion and rebranding will occur post a renovation set to conclude by the end of FY2026. The renovation and rebranding will allow the hotel to reposition itself in the Pune hotel market, which has performed well over past few years. This will be the second Courtyard by Marriott owned by SAMHI Hotels, the other being its highly successful Courtyard by Marriott at Outer Ring Road, Bengaluru.

It has also entered into a management agreement with Marriott for the rebranding of its 114 rooms hotel in Jaipur to a Tribute Portfolio branded hotel. The conversion and rebranding will occur post a renovation set to conclude by the end of FY2026. Jaipur is a key tourist and business destination in India and has over the years drawn strong interest from both domestic and international visitors. The hotel, which is located in the heart of the city, will be redeveloped to be a part of the Tribute Portfolio, which is a collection of characterful, independent hotels drawn together by their passion for captivating design and their drive to create vibrant social scenes for guests and locals alike. The rebranding will allow the hotel to significantly improve its positioning in the market.

In addition, SAMHI has also signed agreements with Marriott for the other four ACIC hotels to be converted from franchise to management agreements.

Mr. Ashish Jakhanwala, Chairman & Managing Director of SAMHI Hotels Ltd. says, "We are pleased to announce a significant milestone in the integration process for the ACIC portfolio.

Over the years, we have demonstrated our ability to drive performance & growth through turnarounds. With the proposed rebranding and conversion to management agreements, these hotels will be repositioned for better performance and improve their contribution to SAMHI".
